

## Curbside Pick-Up Information

Clarkstown's Yard Waste program helps homeowners dispose of materials that are on the Acceptable Yard Waste List.

### Acceptable Yard Waste for Curbside Pick-Up

- ▶ Brush
- ▶ Twigs
- ▶ Hedge Clippings (*tied into bundles less than 5 feet length, and less than 50 lbs.*)
- ▶ Branches
- ▶ Logs (*less than 6 inches in diameter and 5 feet in length*)

### Mixed Yard Waste in Biodegradable Bags

- ▶ Sticks
- ▶ Leaves
- ▶ Yard Rakings

### Drop-Off Yard Waste

The following list is **not picked up** by the Clarkstown Highway Department, but may be dropped off at the Rockland Green's Mulch and Compost Facilities:

- ▶ Grass
- ▶ Thatch
- ▶ Stumps and Logs (*up to 36 inches in diameter and 3 feet in length*)

Residents, in non-commercial vehicles, may drop off yard waste listed above to:

### Unacceptable for Pick-Up Plastic Bags

Plastics are not biodegradable and cannot be mixed in with yard waste.

### Large Piles

Any yard waste that exceeds the acceptable dimensions will require special pick-up, which includes proper equipment, and is weather permitting. Large pile pick-up may take place outside the regularly scheduled dates.

# Yard Waste Pick-Up



## Yard Waste Placement

You or your landscaper must place your yard waste at the edge of your property—not in the street—or arrange for it to be removed.

**For your safety DO NOT place yard waste in the following areas:**

- ▶ In the street
- ▶ At intersections
- ▶ School bus stops
- ▶ Near fire hydrants
- ▶ Over storm drains
- ▶ Over underground utility box

**THIS LAW WILL BE STRICTLY ENFORCED.**

*Pursuant to the NYS Vehicle and Traffic Law, Section 1220.*



## Biodegradable Bags

Mixed yard waste is acceptable for pick-up in biodegradable bags only. Plastic bags will not be accepted. Free biodegradable paper bags are available to residents at the following locations:

- ▶ Town Hall/DEFM
- ▶ Highway Department
- ▶ Recreation and Parks Department
- ▶ Community Centers



## Clarkstown's Landscapers Licensing Law

All landscapers who do business in our town are required to be licensed. This is to ensure that landscapers remain committed to keeping our streets safe by keeping them clear of leaves, twigs, and other types of yard waste. ## Clarkstown Mulch and Compost Site

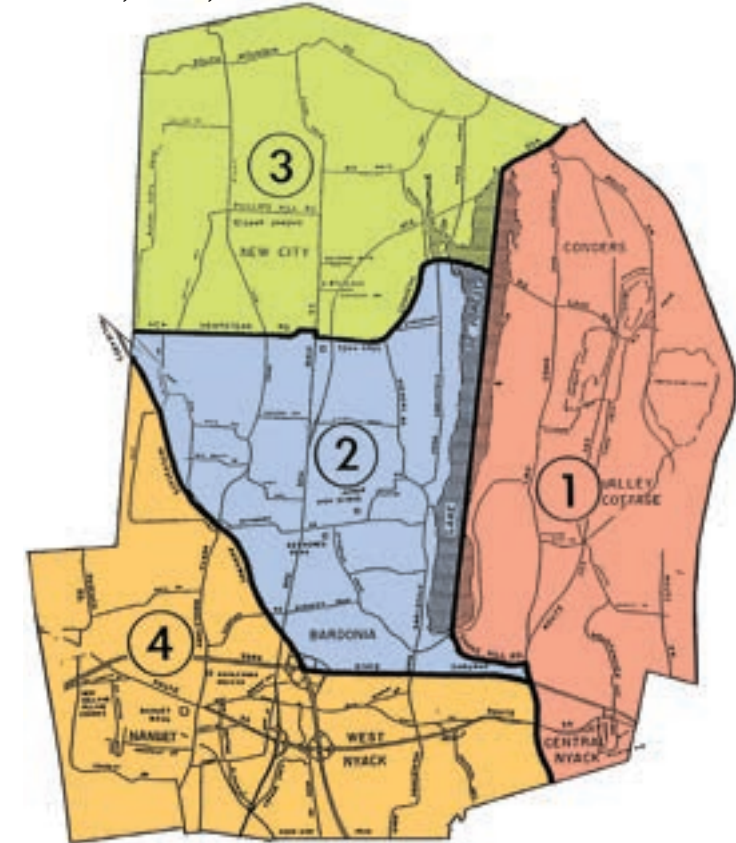
**Germonds Park**

- ▶ Free to Clarkstown Residents (with proof of residency)
- ▶ Self Pick-Up (no commercial)
- ▶ Open: 7 days a week  
7:00 am – 7:00 pm  
April 1st through October 31st

*Disposal of yard waste at this location is prohibited.*

Please find your household area in the map below. Each area consists of approximately 15 routes. Each route has approximately 30 streets. All yard waste must be at the curb by the dates indicated to ensure pick up in your area. All dates are Mondays except for May 30th & September 5th (Tuesdays due to Memorial Day & Labor Day holidays)
